1. Have advance arrangements/bookings been made with all the carriers participating in the carriage of the live animal/s?
2. Have advance arrangements been made at the airport of destination i.e. for quarantine and delivery?
3. In the event of attendants accompanying the animal/s, have advance arrangements been made with all carriers concerned?
4. Does the shipment comply with current regulations in force at transit stations?
5. Where applicable, have carrier/governmental exceptions been complied with?

7. Are all flight numbers for which bookings are held for the entire routing indicated?
8. Are all charges prepaid?
9. Is the quantity and common names of the animal/s shown in the "Nature and quantity of goods" box?
10. Does the "Handling Information" box show a 24-hour emergency phone number?
11. Are all required documentation attached to the AWB (permits, health certificates, CITES)?

Shipper's Certificate (7.1.2)

12. Is it completed in full and in duplicate?
13. Does the description and quantity of animals agree with the information in the Air Waybill?
14. Is it signed by the Shipper or his authorized agent (this must not be an IATA Cargo agent, consolidator, forwarder or indirect carrier)

Container (8.1; 8.3)

15. Does it comply with the specific container requirement as detailed in the IATA Live Animals Regulations regarding:
 - a) Is the size suitable for the particular type of animal?
 - b) Does it provide for sufficient ventilation?
 - c) Is the construction adequate?
 - d) Does it contain adequate handholds/lifting devices to facilitate handling and to prevent the handler from coming into close proximity of the animal?

Container (8.1; 8.3) continued

- e) Is it leak and escape proof?
- f) If possible to check, is the container clean?
- g) Does it contain sufficient absorbent material? (Check that it is not straw)
- h) Does the container have suitable feeding/watering facilities?
- i) Is original documentation securely affixed to the container?

17. If possible to check, does the container contain the correct number of animals according to the Shipper's Certificate and AWB?

19. Is the Consignee's full name, address, and phone number shown on each container?
20. Is a 24-hour contact phone number marked on each container?
21. For Specific Pathogen Free (SPF) animals for laboratory use, are "Laboratory Animals" and "This Way Up" labels attached to each container?
22. Is the correct number of "Live Animals" and "This Way Up" labels attached to each container?
23. Has each "Live Animals" label been completed correctly reflecting the correct contents?
24. For live animals which can inflict a poisonous bite or sting, is the container marked in bold letters "POISONOUS" or "VENOMOUS"?
25. When sedatives, tranquilizers or psychoactive drugs have been administered to the animal, have details been made immediately available with the container i.e., time given, type, dosage and estimated duration?
