Content of this document reflects information about implementation of ICS2 Security filing requirements into existing IATA Air Messaging standards. Recommendation reflects data elements that are used by Descartes Global Security Filing to create PLACI and ENS filings to EU ICS2 system. It does not contain in any way specific airline or 3rd party filing system requirements.

We cannot guarantee that all carriers will adopt the same logic and customers are reminded that they should check with their contracted carriers about any specific requirements they have with regards to Air Messaging content whether related to ICS2 or any other carrier/country requirements.

Also, even where CargoXML (CXML) is used unless you are self-filing via Descartes, then this may need to be converted to Cargo IMP (CIMP) depending on the carrier involved and their capability / configuration / security filing application. This may affect the data being provided to the carrier due to the limitations of CIMP.

1. Mandatory elements for ICS2

Each existing IATA message standard defines mandatory and conditional elements that must be contained within a message to conform with the standard. Below list of elements is independent from such specification as it contains only conditional or optional elements which are required to create an ICS2 filing.

AWB Consignee Postcode	Where the country supports PostCodes (see below).
AWB Consignee EORI	Only where the Consignee has an EU EORI; for a consolidation this is expected to be the receiving forwarder / de-consolidator.
AWB Carrier EORI	This is required to provide the EORI used by the carrier, especially when self-filing.
AWB AGT EORI	This is required to provide the EORI used by the declarant only when self-filing.
AWB Goods Description	Must not be one of the unacceptable goods descriptions (see below) and recommendations regarding Consolidations
AWB Harmonized Commodity Code (HS Code)	6 Digits minimum. See recommendations regarding Consolidations
AWB Master Gross weight	
AWB Shipper Postcode	Where the country supports Post Codes (see below).
AWB Type of Payment - charge code (CVD)	To be converted from IATA codes to EU ICS2 payment codes.
HWB Consignee City	
HWB Consignee Country	
HWB Consignee Name	
HWB Consignee Postcode	Where the country supports Post Codes (see below).
HWB Harmonized Commodity Code (HS Code)

Consolidations

The EU previously advised that, where the cargo at the master level is consolidated from many underlying house consignments, the description of goods at master level can be replaced by the statement ‘detailed goods description as provided from the house level’, provided that the detailed information is filed on the house level.

Regarding the commodity code (HS code), there should not be used any sort of dummy or invented code, but the HS code of one of the goods that are part of the consignments, ideally one that best represents the consolidation as a whole or the one that covers the majority of the consolidation. Again, this only applies if the House level data has the accurate HS Code information.

2. CargoIMP

Most of the data elements listed above are already present in messages today. Below describes how to express EORI number and HS code within CargoIMP FWB and FHL message.

2.1. EORI

EORI in CargoIMP (FWB/ FHL) should be sent in the OCI Segment. Options below describe as to what can be declared in the OCI segment – not all may be required and are just to show where data can be declared including UNDG code or Screening information which is only needed when appropriate, “US” and “DE” are example country codes only.

It is also possible to declare a Third Country ID (TCUID) if the Consignee/ Consignor has one.

For self filers, carriers should declare their EORI in AGT and if a carrier is using Descartes Global Security Filing application they can advise us which AGT EORIs should affect their default filing model and should be declared as a “supplementary filer”. Other carriers may insist on other means to identify self filing.

3. CargoXML

3.1. EORI

EORI should be added to IncludedCustomsNote segment in CargoXML messages. Example of German EORI number as Consignee:

3.2. HS Code

Preference is 1 Sequence Number per Goods Item (per HS code) but it is possible to have 1 goods item with multiple HS codes however matching HS code to goods description will not be as accurate and may lead to Requests for Information from EU Customs.

3.2.1. XFZB

Preferred is 1 item per HS code so that Goods Description is accurate to each HS Code
